Using the system - whistleblowers

Enter <u>https://nordicwhistle.whistleportal.eu/WhistleBlower/Form/547-950-</u> 211e439b4d6c4b918503a088d2ebb34f in your browser or scan the following QR-Code:



You will then be taken to the page where you can leave a message about the irregularities you have become aware of.

You can choose a language you are familiar with from the 12 languages currently available:





Enter as much information as you can and in as much detail as possible. You can attach documentation if you have it.

Finish by pressing 'Send'.
